# About the ISHINE Internship

Ironwood Pharmaceuticals' ISHINE internship is a competitively paid program designed to provide students attending historically Black colleges and universities (HBCU's) with hands-on and meaningful experience in the biopharmaceutical industry. Selected students will have the opportunity to hone a wide variety of professional skills, including effective communication, technical proficiency, business acumen, critical thinking, effective reasoning, and idea development.



ISHINE Interns will spend eight weeks in the summer working on projects under the tutelage of a preceptor/mentor. Throughout the summer, interns also will participate in group activities that enable and encourage interaction with interns and Ironwoodians beyond their own assigned departments. At the end of the program, interns will have the opportunity to present their work to the larger Ironwood community. Ironwood has a hybrid work environment, welcoming both in-office and remote work. All interns will have an opportunity to participate in activities in our Boston headquarters, the expenses for which will be paid by Ironwood.

- Must be enrolled in school the semester following the internship
- Authorization to work in the U.S. without requiring sponsorship
- Other requirements as listed in the specific internship description
